



Equitable Development Initiative 2021 Cohort | Washington, D.C.

Our third cohort for the Washington Metropolitan area Equitable Development Initiative focused on addressing multi-family, affordable housing in the metro area. The series covered the real estate development process, business management, all within the D.C. area development context. All program participants received intensive training through weekly information sessions, advice and support through one-on-one mentorship, and connections to capital.



Carlos Chevez grew up in Washington, D.C., graduated from Cardozo Senior High School, and attended Strayer University where he received a Bachelor's degree in Information Technology.
