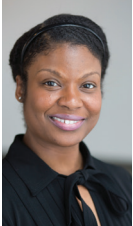




## Equitable Development Initiative 2018 Cohort | Detroit, Michigan

Our first cohort for the Detroit Equitable Development Initiative was divided into two tracks. All participants followed a training track that focused on multifamily and mixed-use neighborhood infill development in Detroit. Additionally, the seven participants below were selected to receive more intensive training including one-on-one support from an established local developer mentor and a real estate development finance expert.
